III. Approval of Minutes

V. President's Report - Craig N. Holmes

a. TASMA Meeting Report - They claim to not have received our RFC (145.280 MHz) that was emailed 2 years prior regarding Fountain Valley. Craig immediately handed them a copy during the meeting. Craig explained to them that we had been operating on the air for 2 years. They said they will eventually coordinate 440 MHz systems when they get a full Board. Next meeting is May 28th.

b. Repeater Updates

- i. Snow Peak & Interference continues.
- ii. Eagle Tower & links improved. Membership reported from the floor that they are still concerned with delay in link timing. Expressed desire for this to be corrected. Membership noted that other systems work faster than ours.
- iii. Los Angeles Need to link in to the overall system. Bob Moore will work on this soon.
- iv. Fountain Valley TASMA will not allow us to move the antenna. Therefore we need a 440 MHz frequency pair.
- v. San Diego Members are trying to get equipment together. Can hit both SP & ET from San Diego Storehouse.
- vi. Piute Peak 8300 ft elevation peak that a Church member owns. Members have gathered quite a bit of equipment. Now trying to get a similar antenna as ET.
- c. Ecom Training Net Cliff Hillquist is heading this up with John Hunter. Cliff is a retired law enforcement officer. He is excited to run the net.
- d. Earthquake Discussion Japan experienced a 9.0 magnitude earthquake on March 11, 2011. Japan has most Hams per capita in the world. No Church ERC program however. Took 3 days to find missionaries. Still don't have 1/3 of members located so far. Southern California is much more prepared.

VI. Vice President Report - James L. Dowdle

a. Jim discussed the potential impact passage of H.R. 607 would have on SCIRA, Inc. He encouraged members present to write letters to government officials. Jim called for a motion.

- d. Jim brought a large number of surplus electronic components which he handed out for free to those interested.

VII. Secretary Report - Aaron M. Scullin

- a. Automatic Packet Reporting System (APRS). Aaron stated that we also consider utilizing APRS text messaging features for ERC messaging capabilities following a disaster. It appears more and more attractive when considering how congested Southern California is getting. APRS has the following benefits:
 - i. Message receipt acknowledgement
 - ii. Auto reply
 - iii. Ability to determine if remote station is on/off or operational/destroyed within minutes of an event occurring.
 - iv. Less chance for errors in message handling
 - v. Messages stored in mailbox
 - vi. As more stakes/wards join the system, the better the capacity of the system.
 - vii. No expensive repeater hardware to maintain.
 - viii. No Coordination issues to deal with.
 - ix. Aaron demonstrated his equipment after the meeting.
