WWW.SCIRAINC.ORG, and a serial number" label on each piece of equipment. If our property is stolen or destroyed we need to have that information by site. We need to know what piece of equipment is at which site. When equipment is taken out of service that needs to be noted, and a replacement label placed on the replacement piece(s) of equipment. The written list for that site should be updated. Companies that have equipment, specially electronic test or measuring equipment have a list of these items. It's just a good business practice.
